



## Tony Chebli

### Summary:

Tony currently is heading the Information Security Department of Group Credit Libanais. He accomplished several security objectives to the Group, among them achieving PCI-DSS compliance for Bank Credit Libanais and sister companies: CCM, Netcommerce, IPN and Credit International Bank in Senegal. To note that Credit Libanais is the only bank in Lebanon to be PCI-DSS certified.

Tony engineered a security program derived from ISO 27001 and PCI-DSS standard which helped the Bank complying to Banking Control Commission (regulator) circulars (222, 272 and others) and satisfying the external and internal IT auditors requirements. In addition, Tony was nominated the project manager for the GDPR compliance within the Group Credit Libanais in addition to be assigned as technical Data Protection Officer.

Tony was involved in numerous IT projects (network, systems and applications: core banking, Swift, online banking, CRM and others) within Group Credit Libanais- his contribution surpasses information security and encompasses other IT areas due to his experience and previous exposure with other organizations.

Tony conducts professional security trainings: CISSP, PECB ISO 27001 Lead Auditor, ISO 27005 Risk Manager, ISO 27032 Lead Cybersecurity Manager and Data Protection Officer. He developed several customized security courses which he delivered to Banks and private organizations in the Middle east Region.

Tony, for more than a decade, conducted/delivered many information security services while working with Deloitte and Secor/Computel group, in the Middle East namely UAE, Lebanon, Jordan, Turkey, and KSA.
